Prerequisites

Graduate standing; instructor permission and requirements as noted in the departmental guidelines. This course is ideally taken the last two semesters of graduate study (counseling) or in the last semester (MFT). Skills learned through other graduate courses (i.e., Theories and Techniques of Individual & Group Counseling, Individual & Diagnostic Testing Techniques, and Competency Based Counseling) are required and will be applied during Practicum.

Objectives

Through practicum, students will provide counseling and testing services, under supervision, in counseling and mental health facilities. Supervised practicum experiences will enable students to further develop their counseling skills in working with diverse clientele. Students are expected to follow the Student Guidelines for Practicum (available on course website).

Requirements

As part of practicum, students will work an average of 13 hours per week (200 hundred hours per semester or 2 credit hours) or an average of 19 hours per week (300 hours per semester or 3 credit hours) at their practicum site and attend practicum class. The practicum class involves the following: review of student concerns, review of student counseling and testing activities, presentations and direct supervision by the instructor and guest speakers, and group supervision of student cases.

Textbook

No specific textbook is required. However, students are expected to explore the books, journals, and other resources that will be referenced.

Attendance

Weekly attendance and punctuality is required. This course provides supervision and administrative guidelines for practicum. In addition, punctual attendance reflects a professional commitment to practicum and professional development. Only excused absences (i.e., illness or other personal emergencies) are acceptable with appropriate documentation. Work and other personal activities are not considered acceptable excuses.

Each week, you are also required to present a log of your hours for the previous week. In addition, at the end of your practicum you will email a complete log of your hours to the instructor. Both logs are available on the website.

Grading

Students will be assessed on the following criteria:

10%	Hours worked and logged
20%	Professional behavior
25%	Quality of counseling work
15%	Class and supervision attendance
15%	Class participation

15% Promptness and professionalism of notes, logs, assignments, etc.

Grades will be assigned based on the following standard:

80 - 89%	В
70 - 79%	С
60 - 69%	D
Below 60%	F

Students receiving a grade lower than an A or a B will not be allowed to complete the class without appropriate remediation.

Site supervisors will participate in the evaluation process and will be requested to complete two written evaluations (MFT and first semester counseling) or one written evaluation (second semester counseling).

Serious violations of the professional and ethical principles will result in a grade of F and the termination of practicum.

UNIVERSITY POLICY

Part of professional training is learning to behave professionally, including high levels of ethical conduct. Students are expected to be on time for class so as to avoid the disruption of learning and participation in discussion.

Non-payment of tuition: Please be aware of the following:

You will not be dropped from classes for non-payment. If you do not or cannot attend class, you must withdraw, or risk receiving 'F's on your transcript, in addition to owing tuition and fees."

Emergencies during final examinations: If an emergency occurs that prevents the administration of a final examination, the student's final course grade will be calculated based on the work in the course completed to that point in time and the faculty member's considered judgment. Final exams will not be rescheduled, and a grade of "I" will not be given as a result of the missed exam. This applies to situations when the administration of the final was impossible, not when an individual student is unable to take a scheduled final.
